



### **ENVIRONMENTAL COMMITTEE**

The Environmental Committee is made up of company leaders and technical experts from a variety of backgrounds working to stay informed about environmental and regulatory issues and engage directly with government regulators on public policy development and implementation. That's no small task as the committee deals with issues involving Pennsylvania state government entities including the Department of Environmental Protection, Fish and Boat Commission, Game Commission, Department of Conservation and Natural Resources, and on the federal level the U.S. Environmental Protection Agency, Fish and Wildlife Service, Army Corps of Engineers, as well as the Susquehanna and Delaware River Basin Commissions.

The committee is divided into four highly active subcommittees: Erosion & Sedimentation, Waterways and Threatened & Endangered Species; Air Quality and Emissions; Water and Waste Management; and Well Construction. Workgroups are created to address specific matters of concern.

Projects and issues currently before the committee include:

- Working with the Independent Petroleum Association of America to participate in public policy and regulatory developments including EPA air emissions ("Quad O" regulations) and various USFWS threatened and endangered species actions (see the Legislative/Regulatory/Legal sheet).
- Proactively engaging with DEP as the department proposes "RACT-CTC" emissions regulations for existing oil and gas wells and related equipment.
- Promoting the development of underground injection wells in Pennsylvania while also developing other cost-efficient alternatives for wastewater disposal.
- Addressing affordable well-plugging solutions and other important legacy well issues.



- Providing input on DEP well construction matters such as area of review, water supply replacement, spill policy, well bore deviation and pressure barrier policy.
- Impacting DEP, SRBC and DRBC actions by participating in the DEP/Oil and Gas Industry Quarterly Meetings and by member participation on several advisory committees including the Oil and Gas Technical Advisory Board and the Pennsylvania Grade Crude Development Advisory Council. Environmental Committee members also attend government meetings, public hearings and other functions.
- Organizing a series of PIOGATech seminars that provide training on environmental matters members deal with on a daily basis. Among the topics address are air quality compliance, endangered species issues, water and waste issues, compliance risk management, and more.

The Environmental Committee is a highly effective group, yet it urgently needs to have more PIOGA members—particularly operators—participate in order to more fully address the industry’s concerns and work for solutions to those problems. Please consider becoming involved.

### MARKET DEVELOPMENT COMMITTEE

For quite some time, this committee was responsible for monitoring developments at the Pennsylvania Public Utility Commission and Federal Energy Regulatory Commission, as well as reviewing pipeline and LDC tariffs and pipeline open seasons, recommending and managing interventions in rate cases, and developing producer policy positions on natural gas marketing matters.

But then came the shale-gas revolution and the committee saw an opportunity to refocus its mission, which coincided with fewer proceedings involving public utilities. Today the Market Development Committee also works actively to accelerate greater use of Pennsylvania-produced natural gas in electric generation, alternative-fuel vehicles, commercial applications, exports, industrial demand, distribution demand, and natural gas conversions from other fuels throughout Pennsylvania and surrounding states. At the same time, the committee continues to monitor and, when necessary, participate in PUC and FERC proceedings. PIOGA has a staff member—Joyce Turkaly—tasked specifically with natural gas market development. As far as we know, no other state trade association has a staff person dedicated solely to helping find new and expanded uses for our natural gas.

These are among the committee’s most recent highlights:

- In 2018, launching Marcellus to Manufacturing, an interactive conference designed to help participants form long-term strategies to assist in capitalizing on the shale-gas phenomenon—prolific natural gas production that will ensure attractive energy costs for commercial and industrial concerns for decades to come.
- Supporting a demonstration project to convert a Pittsburgh-area river towboat from diesel to liquified natural gas. The project aims not only to take advantage of the region’s prodigious natural gas supplies, but will also help make the region’s waterways and air cleaner.
- Providing direct testimony to the Pennsylvania DEP when the possibility of new markets arises. The state’s Driving PA Forward program is providing grants to reduce diesel emissions with compressed natural gas and other alternative-fueling options.

- Actively supporting pipeline infrastructure expansion and projects like Shell's ethane cracker plant in Beaver County.
- Educating PIOGA members about opportunities and trends by organizing field trips to facilities that utilize natural gas in manufacturing operations and facilities that also provide equipment and services to support the oil and gas industry.
- Inviting well-respected subject-matter expert to address committee meetings on a wide range of topics and business opportunities relevant to our membership.

One of the most important functions of a trade association is government relations. Aside from the market, no other factor has a greater impact on your business than government regulations and legislation. PIOGA's Environmental Committee tackles the regulatory side, while the Legislative Committee focuses on the lawmaking process primarily in Harrisburg but also in Washington, D.C., in conjunction with the Independent Petroleum Association of America. The duties of the Legislative Committee, working closely with PIOGA staff and our government relations firm, include:

- Assist with developing PIOGA's legislative agenda.
- Review legislation being introduced and recommend positions and actions to be taken on legislative issues.
- Follow through on calls for action by contacting legislators and encouraging PIOGA members to be active in legislative issues.
- Assist with plans for lobby days, legislative conferences and legislative fund raising.
- Help educate membership on legislative issues through *The PIOGA Press*, PIOGA conferences, the association's website and other forums.



The mission of the PIOGA Safety Committee is to serve members and government agencies as a forum to improve Pennsylvania oil and gas industry safety performance through the exchange and communication of best



practices, education and training, incident review and sharing, and to identify and communicate industry trends. The committee welcomes participation by all members. The committee strives to provide information member companies can use in meeting the varying safety-related requirements of operators and assisting in the training and development of new employees as the industry rebounds. Among the Safety Committee's goals are:

- Organize PIOGATech training sessions on important safety topics.
- Invite subject-matter experts to present at committee meetings.
- Coordinate a monthly safety article in The PIOGA Press.
- Discuss and analyze safety-related incidents, best practices, regulatory matters and other issues impacting oil and gas industry safety.

# NATURAL GAS MARKET DEVELOPMENT

We are justifiably proud that Pennsylvania has swiftly grown to become the nation's number-two producer of natural gas. When compared to alternative methods, natural gas pipelines and related infrastructure are the safest mode of transporting natural gas and natural gas liquids (NGLs) to market. However, not all states have agreed to grant permits that would ease access to those markets. Without considering the backlog of wells that are drilled but unconnected to pipelines, Pennsylvania currently produces three times more natural gas daily than all consumers combined need or demand on a peak day; this gas simply must leave the region to find additional markets.

Opposition also has mobilized against projects ranging from natural-gas-fired power plants to gas-processing facilities and petrochemical plants. Opposition also exists to drilling for and producing the resource and at times there is opposition to the products made from the resource itself, as is the case of NGLs and the associated plastic products that we depend on in our daily lives. Petrochemical and plastic resin manufacturers are strongly considering locating to our region, namely because the resource sits within a 500- to 600-mile radius of the demand centers. Additional energy infrastructure such as NGL storage hubs and distribution network is critical to realize the petrochemical and plastic resin potential of the region. Given the abundant NGLs, the American Chemistry Council estimates potential capital investment may reach as high as \$36 billion. It recognizes the need for workforce numbers at roughly 100,000, direct output of goods at \$28.4 billion and a direct tax benefit to the region (federal, state and local revenue) of \$3 billion by 2025.

Led by our Market Development Committee, PIOGA has been working hard to expand existing natural gas uses, identify and encourage development of new and innovative markets, and educate decision makers and the general public about the benefits of natural gas and the need for more gas and liquids pipeline capacity. PIOGA also has had an advantage we believe is unique among oil and gas trade associations—a staff member dedicated solely to these sorts of issues. That person is Joyce Turkaly, our Director of Natural Gas Market Development. She is an industry veteran who has enthusiastically defined this new type of position and, working alongside members and other stakeholders, has made significant inroads.

In creating and executing PIOGA's downstream business plan, Joyce explains: "I am establishing a personal style and approach that will characterize the association's

dealings with the many stakeholders who conduct business in the region. I have personally introduced PIOGA and our downstream mission to influential stakeholders who are researching or utilizing natural gas and natural gas liquids in downstream markets. I have spent most of my time with PIOGA introducing myself to and creating opportunities for future discussions with strategic national entities such as Department of Energy, American Petroleum Institute, American Petrochemical Manufacturers Association, Energy Equipment and Infrastructure Alliance, and LNG Allies, as well as state-level stakeholders such as the Pennsylvania Manufacturers Association, Pennsylvania Department of Community and Economic Development, Pennsylvania Public Utility Commission and the Department of



Environmental Protection. These relationships ultimately have common ground and hold common goals that in turn help advance our legislative and regulatory efforts.”

Efforts to utilize natural gas in the region where we do business is most important. “The diversity of our membership is such that all subject matter experts sit under one committee and market development questions can be easily answered based on the collective experience of the group,” Joyce explains.

Utilizing such alliances, PIOGA has been able to invite high-quality speakers into the monthly Market Committee discussions, which serves not only to educate our members on relevant topics but also to give them opportunities to become part of an extended network that may not otherwise be available to them. Joyce frequently authors articles for *The PIOGA Press*, sharing cutting-edge information from conferences, the availability of grants and other developments in the downstream arena.

Among the most beneficial relationships for our members are those that have brought PIOGA into the power-generation space. PIOGA has opened doors at PJM, the entity that directs operation of the region’s electricity grid, and we have organized events such as tours of gas-fired power plants that give a first-hand look at how natural gas combined with best available technology is producing reliable electricity to the nation’s energy grid and reducing greenhouse gas emissions and particulate matter.

Joyce and her colleagues look to facilitate project development where practicable. This includes helping match producers with end-use project developers such as distributed generation and opportunities in compressed or liquefied natural gas. “I work with vendors who are seeking to define market opportunities in Pennsylvania,” she says. “If they are successful, PIOGA and its members win as well.”



She continues: The Market Development Committee has evolved to become more of a ‘think tank’ in areas of entrepreneurial ideas and projects. Current projects involve the best available technology for natural gas engines in high horsepower and commercial applications. Natural gas a bridge fuel has many environmental benefits and performance benefits to end users. On behalf of our members, I am more immersed in discussions with local economic development teams from the governor’s office and local counties than ever before. PIOGA has a seat at the table when it comes to natural gas and natural gas liquids market deployment throughout the state. For the most part our members are very knowledgeable in their respective fields; it’s easy for me to meet and make introductions that make sense to move projects forward.”

Recognizing the market potential for CNG and LNG vehicles, Joyce serves on the board of Pittsburgh Region Clean Cities, an organization championing alternative-fuel vehicles and infrastructure. This participation helps PIOGA advance education of the public at large about the advantages of all types of natural

gas vehicles. Further on the transportation front, Joyce notes: “There is great potential to convert engines in any HHP application; locally on the Three Rivers, the marine segment is a great target market for natural gas and LNG.

Of course, PIOGA also has strongly supported Shell Polymer’s ethane cracker plant in Beaver County as part of our downstream initiative. The association has taken part in public meetings and submitted comments in support of the project for DEP air permits. Recognizing the significance that the petrochemical plant has to our members, the committee has hosted Shell representatives to discuss the potential to benefit member companies in anticipation of other types of business and industry that can use our members’ products and services.

In anticipation of the NGL storage hub, Turkaly has been asked by the Tri-State Shale Coalition to represent PIOGA on furthering petrochemical and related industries to the area. “I will continue to look for venues where we can continue to educate on the benefits of natural gas for end use,” she says.

# LEGISLATIVE, REGULATORY & LEGAL ACTIVITY

**G**overnment relations is an essential core mission of PIOGA. Other than market conditions, nothing can impact your business more than what happens in the Pennsylvania General Assembly, the U.S. Congress, a multitude of regulatory agencies, the courts, and even increasingly at the local government level. PIOGA and our allies work constantly to advance your interests in all of these venues.

On our own and in coordination with other trade associations within our industry\* and as part of coalitions with diverse memberships,\*\* PIOGA protected and advanced the interests of the oil and natural gas industry during the past year in the legislative/regulatory/legal sphere. The following are among our recent accomplishments and ongoing government relations priorities. Please refer to the Committee sections for additional issues PIOGA is addressing.



- **Prevented enactment of additional taxes on natural gas and crude oil production.** Beginning with the Rendell administration and carrying forward now into Tom Wolf's second term as governor, each year PIOGA has helped lead the fight against an industry-killing severance tax. Contrary to the governor's statements about pursuing only legislative initiatives in his second term that have bipartisan support and are achievable, he continues to advocate a severance tax. Despite judicial rejection of many protections PIOGA successfully lobbied to include in Act 13, three important victories in the 2012 law that have not changed: (1) limitation of the impact fee to unconventional gas; (2) limitation of the fee on vertical shale wells to 20 percent of the fee on horizontal wells; and (3) keeping the fee's local focus as one of the strongest arguments against a severance tax.

- **Ongoing action against Pennsylvania Public Utility Commission limitation of favorable "stripper well" status for the Act 13 local impact fee.** Despite the Pennsylvania Supreme Court's

reversing the Commonwealth Court's decision that an unconventional gas well not producing more than 90 Mcf/day during any *one* calendar month—instead of *every* month—is a stripper well not subject to the impact fee, PIOGA continues its effort to show the high court that its adoption of the PUC's position ignored undisputed facts and misapplied a fundamental rule of statutory interpretation.

- **Continued advocacy for Conventional Oil and Gas Act (COGA) and vigilance against adoption of unreasonable Chapter 78 regulations for conventional oil and natural gas wells.** As a result of the General Assembly's erasing the new Chapter 78 regulations and requiring any future rulemaking for conventional operations to be unrelated to unconventional operations (Act 52 of 2016) and creating the Pennsylvania Grade Crude Development Advisory Council (CDAC), PIOGA continues to work with CDAC and industry associations representing conventional operators for enactment of COGA as well as the development of new rules and initiatives aimed at boosting the conventional industry.

- **Continued monitoring of PA One Call System's (POCS) implementation of the Act 50 of 2017 changes and advocating for changes in POCS's rates and billing.** PIOGA continues to work on the most effective ways to challenge POCS' failure to implement the Act 50 requirement for representation on the POCS Board of Directors for pipelines associated with (1) conventional and (2) unconventional oil and gas wells. We also await POCS "cost of service" rate study to determine how to effect changes in POCS' methods for recovering and billing for costs of operation, including expanded and required use of Member Mapping.

- **Ongoing lobbying and litigation to clarify the Pennsylvania Supreme Court's PEDF Environmental Rights Amendment (ERA) decision.** The ramifications of the Supreme Court's June 20, 2017, decision concerning the use of Oil and Gas Lease Fund money remain uncertain. PIOGA continues to be involved in activities at every level of government that seek to provide clarity and predictability concerning the ERA's application to the wide variety of circumstances not addressed by the *PEDF* decision.

- **Monitoring and participating in court proceedings to:**

- Categorically reject so-called "community bill of rights" ordinances and home rule charters based on misguided and unlawful notions of a people's retained right of local self-government that is superior to state and federal law, which is used to attempt to ban oil and natural gas operations, including DEP's

lawsuit against Grant Township in Indiana County.

- Reject Environmental Rights Amendment-based zoning rules to divest local governments of their power to zone for oil and natural gas operations based on local considerations.
  - Address the U.S. Fish and Wildlife Service listing of the northern long-eared bat as threatened or endangered, and support expanded Rule 4(d) “incidental take” protection for mining and OGM production and additional forest management activities.\*\*\*
  - Challenge the EPA’s New Source Performance Standards (NSPS, 40 CFR Part 60, Subpart 0000a, “Quad 0a”) regulating methane for the first time and revisions to the Quad 0 regulations regarding volatile organic compounds (VOCs).\*\*\*\*
- **Participating in lobbying/administrative proceedings in opposition to:**
- Pipeline and Hazardous Materials Safety Administration (PHMSA) proposed changes to the scope of pipeline safety regulations regarding production and gathering lines/facilities.
  - Legislation changing Pennsylvania’s Guaranteed Minimum Royalty Act.
  - DEP proposed additional regulation of methane emissions by our industry, including limiting the impact of Reasonably Available Control Technology (RACT) requirements on low-volume wells and affected operations.
  - Unreasonable requirements related to ESCGP-3.
  - EPA’s inclusion of conventional oil and natural gas extraction facilities in its prohibition of wastewater discharges to “publicly owned treatment works” (POTWs).
  - Limit DEP’s use of the “participation theory” to impose personal liability upon operators to plug abandoned wells.
  - DEP’s unreasonable conventional well plugging initiatives.
- **Participating in lobbying/administrative proceedings in support of:**
- Enactment in federal law (via H.R. 245) of PIOGA’s Allegheny National Forest Minard Run litigation results defending exercise of private OGM rights in the national forest.
  - Favorable shipper and gas quality rules in Federal Energy Regulatory Commission matters.
  - Favorable rates, rules and practices for conventional operators on the Peoples Natural Gas companies’ systems.

# PIOGA OUTREACH

**W**e've all heard how carelessly the word *fracking* is used to mean oil and gas development in general. We as an industry know hydraulic fracturing as a technology (along with directional

drilling) that has revolutionized our business and resulted in an abundance of affordable crude oil and natural gas that benefits not only Pennsylvania but the United States and much of the world as well. Yet thanks to a steady drumbeat of misinformation, fracking in the public eye is shorthand for water pollution, air pollution, noise, traffic congestion, unwanted pipeline projects, loss of local government control and many other evils.

We know the truth is far different than what is routinely reported in the media. That's why public outreach is so important to PIOGA's mission. Working closely with other supporters, we tell the story of how natural gas development is benefitting Pennsylvania—how it has put people to work, how lease income helps to sustain family farms and generate hundreds of millions of dollars for state government, how the Act 13 impact fee helps communities, how clean-burning natural gas has improved the Commonwealth's air quality, how so many of the charges leveled against the industry are simply false.

PIOGA representatives routinely speak out at hearings and other public events, meet with state and federal legislators, have letters to the editor and op-eds published in newspapers, and are frequently quoted as news sources by the media.

your community. ## PIOGA's Pennsylvania Energy Education Program

In this time of energy transition, it is essential that citizens be energy literate so they can make informed choices about everything from choosing how to heat their home to potential career paths. Recognizing this need, we developed the PIOGA Energy Education Program, or PEEP, to provide an overview of age-appropriate energy education by introducing several highly interactive activities that can be adapted within various classroom scenarios. It is a "teach-the-teachers"

Our program can be adapted to any discipline in the school. Many people think of it as a "science" class, but our materials were designed to be used by math, economics, social studies, language arts and science teachers. The program is taught as a one-day professional development workshop. It is offered at no cost to the teacher and includes credit hours and instructional materials. Teachers must be willing to share this information with their students within several weeks of the workshop.

PEEP was rolled out in late 2013 and since then 169 educators have gone through the program. Attendees included elementary teachers; middle school science, math and technology teachers; and high school science and economics teachers. An educator on average will reach 90 students a year. Based on those numbers PEEP helped generate over 50,000 energy-aware citizens since the inception of the program. PEEP is a standalone non-profit 501(c)(3) organization and accepts tax-deductible donations and other funding to help sustain this worthwhile initiative.
